

「Video Editor」 User Agreement

Welcome to use 「Video Editor」 !

In order to provide you with better services, please carefully read the "「Video Editor」" User Service Agreement (hereinafter referred to as the "Agreement"). Before you start using the "「Video Editor」" software and related services, please be sure to read and fully understand this agreement, especially the terms involving exemption or limitation of liability, terms of rights, licenses, and information use, and agreement to open and use special Individual service terms, applicable laws and dispute resolution terms, etc. Among them, important content such as exemption or limitation of liability will be reminded in bold form, and you should focus on reading. If you are under the age of 18, please read and fully understand this agreement accompanied by your legal guardian, and use the "「Video Editor」" software and related services after obtaining the consent of the legal guardian.

Unless you fully accept the entire content of this agreement, you have no right to download, install, register, log in, use (hereinafter collectively referred to as "use") "「Video Editor」" software, or use "「Video Editor」" services in any way, Or obtain any service provided by the "「Video Editor」" software (collectively referred to as "use" in this agreement). 1. Scope of application

3. Use the service
